Campaign Finance Update*

*All numbers are current as of July 31, 2020

- Update on current ProJECT Forward Pledges:
 - Total Pledged (17 Units): \$1,621,780 - Total Cash Gifts: \$579,892.75

Balance in ProJECT Forward: \$496,644

- Update on ProJECT Forward Expenses
 - "Interfund Loan" loan for 536 Cornell property has been fully repaid
 - Architect & Capital Campaign Consultant (including publishing expenses)
 have been paid using previously budgeted "Property Fund" balances
- Operating Fund Update
 - Giving Income has been strong & Expenses reduced due to COVID-19
 - Net Income was \$12,334

Construction Manager Selection Process

- 3 Candidates: Schramm (St. Charles) Berglund (Chicago) Sequoia (Aurora)
- Each company submitted an RFP (Request for Proposal) based on our needs
- Interviews conducted on 8/6 & 8/7
- A matrix comparing all candidates was created to aid decision, including:
 - o Cost Estimates, Company Size & Finances, Experience w/Churches & Educational Centers, etc.
- PRT nominated Schramm Construction as best fit (letters emailed 8/13)
 - Contracting for "Pre-Construction" details & final cost determined this week*

*These costs will not exceed our "Capital Improvements" budget line of \$20,000 for 2020 (hence no vote tonight)
