YOUR INVITATION-TO-GIVE

You may ask: "What should I/we consider giving so we can accomplish the proposed projects?" Only God can give you this answer. We can, however, offer some giving challenges that will stretch your faith and help us meet our project goals.

All gift commitments, both small and large, will be needed to meet our project goals. Not everyone can commit to the same amount. Base your commitment on prayer, your personal circumstances, and on how God is leading you. Here are some giving ranges to pray about:

Matching Gift - A Matching Gift means giving to our Capital Campaign over the next three years, the same amount you give to the General Fund. For example, if you are giving \$25 a week (\$1,300 a year) to our church's ministry, would you pray and consider giving an additional \$25 a week to the Capital Campaign for a period of three years? **OR**,

Pacesetter Gift - You may want to pray and consider making a Pacesetter Commitment of \$5,000 - \$20,000, or more. **OR**,

Legacy Gift - It may be possible for you to pray and consider making a Legacy Gift of \$20,000 - \$100,000 or more over the next three years.
